MINUTES OF PARISH COUNCIL MEETING Held at 7.30pm on 21 July 2022 at The Guildhall, Cound

28.22 Apologies for Absence

Apologies were received from Councillor K Symonds.

29.22 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared
- b) There were no applications for a dispensation regarding disclosable pecuniary interests
- **30.22** Public Participation Session a period of 15 minutes will be set aside for the public to speak, with a strict 5-minute limit per speaker. Members of the public may speak on matters appearing on the agenda. However, if a matter does not appear on the agenda, a written request should be submitted to the Clerk no later than 2 working days before the meeting.

No members of the public were present.

31.22 To approve the minutes of the Parish Council Meeting held on 26 May 2022

that the minutes of the Parish Council Meeting held on 26 May 2022 be accepted as a true record. The minutes were signed accordingly.

32.22 Clerk's report on matters arising since the Parish Council Meeting of 26 May 2022

- Submitted AGAR to external auditors PKF Littlejohn before stated deadline.
- Published annual accounts for 2021/22 to website together with Notice of Public Rights to view any records between 13 June to 22 July.
- Researched and prepared Press and Media Protocol (item 36.22).
- Advised Shropshire Council of Councillor Bill Howarth's resignation and subsequently Notice of Casual Vacancy was published by Shropshire Council and Cound Parish Council.
- Once it was confirmed that an election would not be held, advert published inviting expressions of interest in casual vacancy (item 40.22)

33.22 To receive report from Shropshire Councillor and/or Safer Neighbourhood Team (West Mercia Police)

Nobody from the SNT was in attendance.

Councillor Wild presented her report that covered:

- Water Safety during the hot weather young people are tempted to cool off in the river and reservoirs. Please make people in the parish aware of the risks.
- Cound Arbour Bridge following the recent damage to the bridge, Councillor Wild has spoken with Gurnek Singh at Shropshire Council and it has been agreed that the repairs will be left until later in the year when the temporary experimental road layout trial is brought into effect. There have been similar problems with a bridge in Clun and CCTV has been installed there and Councillor Wild has suggested this is done in Cound too. It could act as a deterrent and, in the event of damage being caused to the bridge, the number plate of the vehicle involved could be identified and an insurance claim could be made.
- White Lining On Monday 25 and Tuesday 26 July, following the road resurfacing, the white lining will be carried out on the A458 from Cross Houses to the Cound Junction. This will involve a full road closure from 09:30-16:00.
- Integrated Care System From 1 July the Clinical Commissioning Groups (CCGs) have been replaced by the Integrated Care Systems (ICSs). ICSs are partnerships of organisations that come together to plan and deliver joined up health and care services, and to improve the lives of people who live and work in their area. NHS Shropshire, Telford and Wrekin (NHS STW) and the two unitary councils (Shropshire Council and Telford & Wrekin Council) jointly form a statutory committee called the Integrated Care Partnership (ICP). The ICP will bring together a broad alliance of partners involved in the delivery of health and care services. Councillor Wild has expressed her view to the ICP and the Integrated Care Board (ICB) that the monitoring of outcomes and performance data is vital to success.

34.22 To receive the defibrillator audit check for the period

Councillor Roberts had performed the audit checks for the period up to 18 July and advised that the adhesive pads had been replaced. Discussions were still ongoing between the residents of Cound Park as to where the self-funded defibrillator would be sited in the area.

35.22 Guildhall Matters

Councillor Sartain provided a brief update: With the new floor and radiators installed and the hall looking very good, a meeting will be taking place soon to discuss opportunities to get more business. A wedding reception the previous weekend had been a big success and there were a number of other events booked in shortly.
