# MINUTES OF PARISH COUNCIL MEETING Held at 7.30pm on 16 November 2023 at Cound Moor Village Hall

#### 60.23 Apologies for Absence

Apologies were received from Councillor R Sartain.

#### 61.23 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared
- b) There were no applications for a dispensation regarding disclosable pecuniary interests
- **62.23 Public Participation Session** a period of 15 minutes will be set aside for the public to speak, with a strict 5-minute limit per speaker. Members of the public may speak on matters appearing on the agenda. However, if a matter does not appear on the agenda, a written request should be submitted to the Clerk no later than 2 working days before the meeting.

There were no members of the public present.

#### 63.23 To approve the minutes of the Parish Council Meeting held on 21 September 2023

The minutes of the previous meeting had been circulated.

It was proposed by Councillor Roberts and seconded by Councillor Davies and

that the minutes of the Parish Council Meeting held on 21 September be accepted as a true record. The minutes were signed accordingly by the Chairman.

#### 64.23 Clerk's report on matters arising since the Parish Council Meeting of 21 September 2023

- Adoption of payphone kiosk application submitted to BT to adopt kiosk in Upper Cound. BT are unable to act until the current consultation period is up (end of November 2023) regarding the removal of 19 payphones in Shropshire.
- Costings of siting a defibrillator in BT payphone kiosk research carried out into the costs involved. To be discussed at item 70.23.
- Website hosting a refund had been received from HugoFox for the direct debit payment made in October when they had introduced a monthly fee for website hosting. However, following correspondence with the provider, it was agreed that it was unfair

to introduce payment midway through a financial year and that charging would not now commence until April 2024.

## 65.23 To receive report from Shropshire Councillor

Councillor Wild briefed the Parish Council that on 5 and 6 December there would be some drilling taking place on Cressage Bridge and it would therefore be closed both days between 9.30am and 4.00pm. Full repairs would be carried out at some point between January and May 2024 which would involve the bridge being completely closed for a period of approximately 2 weeks.

A large concrete block had appeared on Cound Bridge with speculation about it possibly being a camera mount. Councillor Wild said that this was a possibility as there were plans for temporary CCTV to be sited there to capture bridge strikes and to monitor larger vehicles crossing over. Since the meeting, Shropshire Council's Engineering Services and Bridges Manager (Gurnek Singh) has confirmed that this is indeed the case.

It had also been reported to Councillor Wild that the red and white trief kerbs on Cound Bridge have been knocked out of place. They are obviously doing their job but they need putting back in the correct place as they are narrowing the carriageway. Gurnek Singh has advised that the kerbs will reset with pins/bedding concrete whilst the trial is carried out and it is hoped this will be for a minimum 6-month period.

#### 66.23 To receive the defibrillator audit check for the period

Councillor Roberts had performed the audit checks for the period up to 12 November and confirmed that both defibrillators were ready to use as and when required.

#### 67.23 Guildhall Matters

In Councillor Sartain's absence, Councillor Roberts provided a brief update: The toilet rebuild has been completed with only a small amount of decorating left to be finished. Very positive feedback so far and quite a few bookings in the diary.

## 71.23 To consider the safety of the ford at Bull Hollow

Councillor Hall showed photographs of recent incidents at Bull Hollow where, when the area was flooded, drivers had been unable to identify the boundary of the road and cars had "fallen" over the edge of the road causing serious damage to the vehicles. It was suggested that either signage be erected directing drivers away from the edge or that bollards are installed for the purpose of clear demarcation of the boundary. It was agreed that Highways at Shropshire Council should be contacted, apprised of the situation, and asked to put in place some remedial measures.
